Because the teacher licensure requirements are subject to change, students should <u>utilize APAS onestop.umn.edu/academics/apas</u> to accurately track progress in the licensure program and work with their faculty and department advisors to complete all internal and external requirements for licensure recommendation. You have four years to complete the requirements listed on your guide sheet and apply for the license. Any courses more than four years old may need to be repeated. When all requirements have been completed, visit <u>cehd.umn.edu/teaching/additional/</u> for instructions on applying for your state license.

The completed review is based on our assessment of your academic coursework. All applicants must meet minimum College of Education and Human Development requirements for GPA. If you believe we have not properly credited you for courses previously taken, you may petition. You will need to provide a detailed course description or syllabi in support of the petitioned request.
